- You agree to provide accurate, current, and complete information when creating an account.
- You are solely responsible for all activities that occur under your account.

## **5. USE OF THE PLATFORM**

You agree not to use the App:

- To abuse, harass, impersonate, or intimidate any person;
- To post or transmit any content that is infringing, defamatory, obscene, or otherwise objectionable;
- To interfere with or disrupt the services or servers connected to the App.
